**ARTICLES OF INCORPORATION**  
**SOUTHWEST DADE ADULT DAY CARE CENTER, INC.**  
In compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I - NAME OF CORPORATION**

The name of the not-for-profit corporation shall be Southwest Dade Adult Day Care Center, Inc.

**ARTICLE II - DURATION**

The not-for-profit corporation shall have a PERPETUAL existence unless dissolved according to law. Corporate existence shall commence upon filing of Articles of Incorporation with the Secretary of State for the State of Florida.

**ARTICLE III - PURPOSE OF CORPORATION**

The not-for-profit corporation is organized exclusively for religious, charitable, scientific, literary and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The not-for-profit corporation is evolved for the express purpose of providing a broad strategic framework of operation that enhances the development and conservation of the community and its resources regardless of race, age, gender, or cultural diversities within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the corporation is then located, exclusively for such purposes.

The general nature and objectives of this not-for-profit corporation shall be as follows:

- 1) To provide a secure and comfortable adult day care center servicing the low income community fifty-five (55) years or older.
- 2) To provide social, therapeutic, recreational, spiritual and other social services and seminars to individuals fifty-five (55) years or older
- 3) To provide supportive services to individuals, families and other care facilities for the compassionate, safe and dignified
- 4) To assist those individuals fifty-five (55) years or older to maintain their independence and self-esteem as long as possible.

#### **ARTICLE IV - MANNER OF ELECTION OF BOARD OF DIRECTORS**

The Board of Directors will be elected in accordance with the adopted By Laws of the Corporation.
