ARTICLES OF INCORPORATION OF

St Saba Orthodox Society INC.

In Compliance with the Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the Corporation shall be: St Saba Orthodox Society INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized: Religious Corporation with a Mission to deepen the understanding of Christianity among Arab-Americans. Further, said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

<u>ARTICLE IV PROHIBITED ACTIVITIES</u>
