ARTICLE I NAME

The name of the corporation shall be: Beginning Steps Ministry Parent Teacher Organization, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: to enhance and support the educational experience at the Beginning Steps Ministry, to develop a closer connection between school and home by encouraging parent involvement, and to improve the environment at Beginning Steps through volunteer and financial support.

ARTICLE IV DISSOLUTION OF ASSETS

In the event of dissolution of the Beginning Steps Ministry Parent Teacher Organization, Inc., the executive board of directors shall, after paying and making provisions for the payment of all liabilities, distribute all the assets of the corporation over to the Beginning Steps Ministry of Bradfordville First Baptist Church or in the event of the dissolution of the Beginning Steps Ministry, funds shall be distributed to an organization dedicated to charitable and/or educational purposes and which has been recognized as a 501(c)(3) organization by the Internal Revenue Service.

ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected and appointed: Initial election of directors was held by the organizing committee. Thereafter, directors of the Parent Teacher Organization will be elected on an annual basis as set forth in the bylaws.

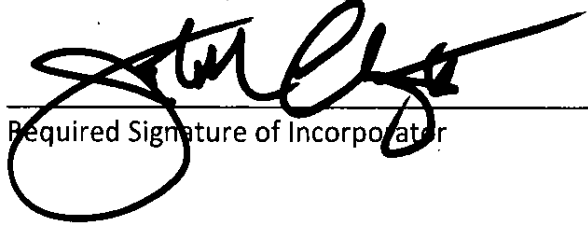
