

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation, hereby adopts the following amendments to its Articles of Incorporation:

The Articles of Incorporation of ASSOCIATION FOR PREVENTION OF CARDIAC ARREST IN TEEN ATHLETES, INC. (the "Corporation ") are hereby amended as follows:

(1) Article III shall be modified in its entirety to state the following:

"The specific purpose for which this corporation is organized is: TO PROVIDE FOCUSED CARDIAC SCREENING FOR TEEN ATHLETES AND PROMOTE AWARENESS AND PREVENTION OF SUDDEN CARDIAC DEATH SECONDARY TO HCM, A GENETIC, CONGENITAL HEART ABNORMALITY. THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, AND SCIENTIFIC PURPOSES UNDER SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE, OR ANY CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE."

(2) A new Article IX shall be added and state the following:

"Article IX

Upon dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."

The date of each amendment is the 4th day of January, 2013.

Adoption of Amendments: There are no members or members entitled to vote on the amendments. Directors of the Corporation have not been selected. The signatory below, the incorporator of the Corporation, adopted the within amendments:
