The undersigned, for the purpose of associating to establish a corporation for the transaction of the business and the promotion and conduct of the objects and purposes hereinafter stated and for the objective purpose of forming a Christian Company recognizing the Bible as the Divine Word of God, under the provisions and subject to the requirements of the Laws of the State of Florida, and we do hereby file these Articles of Incorporation in writing and do hereby state as follows, to wit:

ARTICLE ONE
NAME

The name of the corporation is:

MINISTERIO REINO DE DIOS, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The general nature and purpose of this corporation is to engage in the following activities:

- A.) The authority to engage in and transact, within and without the State of Florida or the United States, any and all lawful activities permitted under the laws of the United States and/or of the State of Florida for which corporations may be incorporated under Chapter 617 of the Florida Statutes;
- B.) The Corporation may more particularly engage in the following businesses and/or activities:
 - 1.) To encourage and promote the evangelization of the world;

- 2.) To encourage and promote the worship of God;
- 3.) To encourage and promote the edification of believers;
- 4.) To provide a basis of fellowship among Christians of like faith;
- 5.) To establish, own and maintain electronic media facilities;
- 6.) To establish a place of worship of God, with Sunday school for the promotion of Christian values;
- 7.) To engage in the media industry for the intent and purpose of effecting commercials, productions, programming and any and all other industry activities, directly or indirectly related thereto;
- 8.) To engage in the business of providing any and all media related services including but not limited to the production and development of commercials, programs, videos and other services affecting the business;
- 9.) To engage in the financing, production and selling of radio and television programs; and to broadcast, disseminate, distribute, transmit, retransmit, receive or collect by electronic or any other means, music entertainment, news, speeches, sermons, advertising, educational and informative matter, photographs, pictures, scenes, or plays and to provide for the use of other facilities for such purposes;
- 10.) To manufacture, distribute and sell audio records, computer programs, and magnetic tape cassettes, compact disc or other mechanical or electronic recordings; to manufacture, distribute, produce and sell video tapes of all types of ministry, preaching, teaching, etc.;
- 11.) To print, distribute and circulate on a national and international basis, books, pamphlets, periodicals, papers, newspapers, newsletters, and magazines in connection with the Kingdom of God and the propagation of the Gospel of Jesus Christ;
- 12.) To promote, foster and encourage the Christian faith on a national and international basis through the preparation, publication, distribution and circulation of study notes, literature, pamphlets, magazines and periodicals, and other type of publications. To acquire all rights in literary properties and publish the same on a royalty basis; to publish under contract in literary properties of others; and to buy lease, and maintain, and dispose of real property, buildings, print plants, printing presses, and such incidental machinery and appliances as may be necessary or useful in such business;

- 13.) To apply for, obtain, register, purchase, lease, or otherwise to acquire and to hold, own, use, develop, operate and introduce and to sell, assign, grant licenses or territorial rights in respect to or otherwise to turn to account or dispose of any copyrights, trademarks, brands, labels, patent rights or letters or patent of the United States, or of any other country or government.
- 14.) To engage in the business of import and export and all matter arising from or in connection with said activity;
- 15.) To engage in the real estate business and as broker, and in any lawful capacity, and generally to take, lease, purchase, or otherwise acquire, and to own, use hold (including holding for investment), sell, convey, exchange, lease, mortgage, work, clear, improve, develop, divide, and otherwise handle, manage, operate, deal in and dispose of real estate, real property, lands, multiple dwelling structures, houses, buildings, and other works and any interest or right therein;
- 16.) Furthermore, the corporation may take lease, purchase or otherwise acquire, and own, use, hold, sell, convey, exchange, hire, lease, pledge, mortgage, and otherwise handle, and deal in and dispose of, as principal, agent, broker, and in any lawful capacity, such personal property, chattels, rights, easements, privileges, choses in action, notes, bonds, mortgages, and securities as may lawfully be acquired, held, or disposed of, and in general deal with, as principal, agent, broker, and in any lawful capacity, mortgages and other interest in real, personal and mixed properties;
- 17.) And may carry on a general construction, contracting, building, and realty management business, as principal, agent, representative, contractor, subcontractor and in any other lawful capacity;
- 18.) And to engage in any and all real estate activities both domestic and foreign and effect the purchase and sale of all kinds of real estate property of whatever nature and wherever situated.

ARTICLE SEVEN
BY-LAWS

The initial By-laws of this corporation shall be adopted by the directors and shall be altered, amended or repealed from time to time by the Board of Directors.

ARTICLE EIGHT
AMENDMENT OF ARTICLES OF INCORPORATION

The shareholders are given the right to amend or repeal any provision contained in these Articles of Incorporation, provided that a majority of the shareholders approve of such amendment or repeal. Amendments to the Articles of Incorporation shall be adopted and approved in the manner set forth under Florida law by the shareholders.

ARTICLE NINE
DISSOLUTION

The Corporation may be dissolved only with the consent given in writing and signed by two-thirds (2/3) of the Board of Directors. Written notice of a proposal to dissolve setting forth the reasons therefore and the disposition to be made of the assets shall be provided to every member of the Board of Directors at least sixty (60) days in advance.

ARTICLE TEN
DISTRIBUTION OF ASSETS

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.

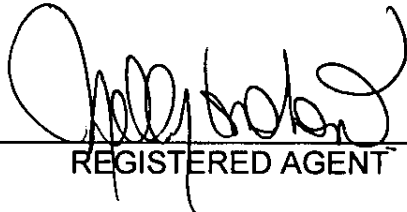
