# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF HIDDEN RIVER TOWNHOMES ASSOCIATION THE HASSEE, FLORIDAD.

(A Florida corporation not for profit)
Pursuant to Section 617.1002 of the Florida Not For
Profit Corporation Act

We, Nicolas Aparicio and Brian Howell, as President and Secretary, respectively, of HIDDEN RIVER TOWNHOMES ASSOCIATION, INC., a Florida corporation not for profit ("Association"), do hereby certify under the seal of the Association as follows:

WHEREAS, the Association was originally incorporated on December 14, 2012, Document Number N12000011619, under Chapter 617 of the laws of the State of Florida; and

WHEREAS, the Amended and Restated Articles of Incorporation of the Association were filed on April 9, 2013 ("Articles"); and

WHEREAS, in accordance with Article XIII of the Articles, after the First Conveyance, and prior to the Turnover Date, the Articles may be amended solely by a majority of the Board, without the prior written consent of the Members, at a duly called meeting of the Board; and

WHEREAS, the Board, by a majority vote, at a meeting held on Sydramber 18, 2013, approved this Amendment.

NOW, THEREFORE, the Articles are hereby amended as follows:

- 1. The recitations set forth herein are true and correct and are incorporated herein by reference.
- 2. Capitalized terms used herein and not defined shall have the same meaning as set forth in the Declaration of Covenants, Restrictions and Easements for Hidden River Townhomes, the Amended and Restated Articles of Incorporation and/or Bylaws of the Association, unless the context indicates a different meaning.
  - 3. Article V, Section D.2. is hereby amended in its entirely to read as follows:
  - 2. "Class "B" Member" shall be Declarant, who shall be entitled to three (3) times the total number of votes of the Class "A" Members plus one. Class "B" membership shall cease and be converted to Class "A" membership upon the earlier to occur of the following events ("Turnover Date"):
  - (i) Three (3) months after the conveyance of ninety percent (90%) of the total number of Homes permitted to be constructed as part of Hidden River Townhomes by Declarant, as evidenced by the recording of instruments of conveyance of such Homes amongst the Public Records of the County;

- (ii) upon the Class B Member abandoning or deserting its responsibility to maintain and complete the amenities or infrastructure as disclosed in the Hidden River Townhomes Documents. There is a rebuttable presumption that Declarant has abandoned and deserted the Total Property if Declarant has unpaid Assessments or guaranteed amounts under Section 720.308 of the HOA Act for a period of more than two (2) years;
- (iii) upon the Class B Member filing a petition seeking protection under Chapter 7 of the Federal Bankruptcy Code;
- (iv) upon the Class B Member losing title to the Total Property through a foreclosure action or the transfer of a deed in lieu of foreclosure, unless the successor owner has accepted an assignment of developer rights and responsibilities first arising after the date of such assignment;
- (v) upon a receiver for the Class B Member being appointed by a circuit court and not being discharged within 30 days after such appointment, unless the court determines within 30 days after such appointment that transfer of control would be detrimental to the Association or the Members; or
- (vi) At such time as Declarant shall designate in writing to the Association.

On the Turnover Date, Class "A" Members, including Declarant, shall assume control of the Association and elect not less than a majority of the Board.

Notwithstanding the foregoing, Class A Members are entitled to elect at least one (1) member of the Board when fifty percent (50%) of the Homes have been conveyed to Members other than Declarant.
