Ministerios Casa de Milagros – Articles of Incorporation

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law and in compliance with Chapter 617 of Florida State Law do hereby certify:

ARTICLE 1 - NAME

The name of the organization shall be Ministerios Casa de Milagros, Inc.

ARTICLE 2 - PRINCIPAL OFFICE

The principal place of business and mailing address of Ministerios Casa de Milagros, Inc. in the state is located in Lee County, in the city of Bonita Springs. The corporate mailing address is Ministerios Casa de Milagros, Inc., 10421 Pennsylvania Ave, Bonita Springs FL 34135.

ARTICLE 3 - PURPOSE OF CORPORATION

Ministerios Casa de Milagros, Inc. is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 50(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Ministerios Casa de Milagros is to be a full-gospel, charismatic, evangelical, nondenominational organization with a heart for winning the lost and edifying and equipping the saints through worship, missions, and sharing the Gospel of Jesus Christ and its tenants of faith.

ARTICLE 4 - MANNER OF ELECTION

Any directors not listed in Article 5 of this document shall be elected by a majority plus one (1) of the vote of the Board of Directors.

ARTICLE 5 - DIRECTORS

There shall be at least three (3) Directors. The method of election and removal of members of the Board of Directors shall be stated in the by-laws. Directorship shall not be denied to any person based on race, color, gender or national origin. The names and addresses of the members of the Board of Directors are as follows:

Ministerios Casa de Milagros – Articles of Incorporation

ARTICLE 6 – INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and address of the registered agent of this corporation is Stevie Ray Luna, 27851 Washington St., Bonita Springs FL 34135.

ARTICLE 7 – INCORPORATOR

The name and address of the incorporator is: Theodore W. Hepperlen, 8112 Pelican Rd., Fort Myers FL 33967

ARTICLE 8 – PROHIBITIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Second hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 9 – LIABILITY FOR DEBTS

Neither the members nor members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.

ARTICLE 10 – AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by a majority plus one (1) of the Ministerios Casa de Milagros, Inc. Board of Directors.

ARTICLE 11 – DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
