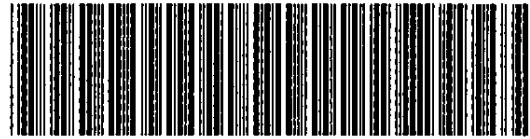

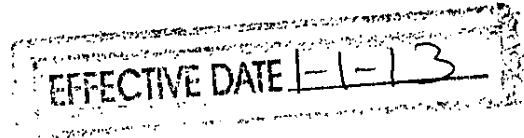

*The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617.1006, Florida Statutes, for the purpose of forming a not-for-profit corporation hereby adopt(s) the following Articles of Incorporation:*

**ARTICLE I – NAME OF CORPORATION**

EFFECTIVE DATE 1-1-13

The name of the corporation shall be: **TOTAL LIFE WORSHIP CENTER INC.**

**ARTICLE II - PRINCIPAL OFFICE/MAILING ADDRESS:**

The principal place of business and mailing address for this corporation shall be:

**ARTICLE III – CORPORATE PURPOSE**

The General Purpose or Purposes for which the corporation is organized is: Exclusively for Religious, Charitable, Scientific, Educational, Health and Spiritual, Social, Economic development, and distinct ecclesiastical purposes, as stated and purposed within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding provisions of any future United States Internal Revenue law as now enacted or hereafter amended including, the making of distributions to organizations that also qualify as section 501(C)(3) exempt organizations.

The Specific Purpose or Purposes for this corporation is to conduct a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable word of God. The purpose of this church is to walk according to I Thessalonians 5:23. Pursuant thereto, the following activities and guidelines shall be established:

1. **SPIRITUAL** – Give practical understanding how to live as a spirit-filled person in the natural.
  - a. Minister the Word of God to the faithful, and all others.
  - b. To give understanding of who Spiritually the person is in Christ.
2. **WORSHIP** – To participate in public worship services together and to maintain personal daily devotions. Recognized Creed, Code of Doctrine discipline and form of worship shall be established.
3. **FELLOWSHIP** – To encourage support and pray for each other as members of the family of God. To share our lives together.

4. **MINISTRY/SERVICE** – To serve unselfishly, meeting the physical, emotional, and needs of those in our Church, Community, and the World at large.
  - a. Ordination of ministries upon completion of the prescribed course of study, designated by the church ministry.
  - b. Established Establishment of a congregation membership based upon acceptance of a recognized creed and belief and support of the church.
  - c. An organization of ministers shall be established to minister to the congregation of TOTAL LIFE WORSHIP CENTER INC.
  - d. Establishment of a congregation membership based upon acceptance of a recognized creed and belief and support of the church.
  - e. Establishment of various religious services pursuant to the recognized Creed, form of worship, code of doctrine and discipline of the church and the establishment of Sunday Schools and religious Schools for Christians and education instruction to the young and to the old.
  - f. To provide counseling and assistance to individuals and families on all topics including, but not limited to, family therapy, couples and relationship therapy, child and adolescent counseling, parenting, grief counseling, marital and premarital counseling, sexual abuse, domestic violence, career counseling and divorce and separation issues.
5. **EDUCATION** – To help members develop toward full Christian maturity and train them for effective ministry. To promote personal, spiritual growth, and discipleship through the Bible teaching.
  - a. To educate the Body Of Christ (The Church) On Leadership, Vision, Church Development and Growth.
  - b. To provide and arrange for workshops and seminars on selected topics and issues relating to the Center's counseling focus.
6. **EVANGELISM/MISSION** – To share the good news of Jesus Christ with as many people possible in our community and throughout the world.
  - a. Structured support services for Evangelistic and Missionary outreaches.
  - b. Spread the Word of the Gospel through seminars, radio, television, establishment of church literature, and other forms of mass media for the purpose of educating the individual in the Word of God.
7. **SOCIAL and ECONOMIC DEVELOPMENT** – Establishment of various religious services pursuant to the recognized Creed, form of worship, code of doctrine and discipline of the church and the establishment of Sunday Schools and religious Schools for Christians and education instruction to the young and to the old.
  - a. This nonprofit religious benefit corporation in accordance with the Doctrine of the Corporation's creed/bylaws shall commence building, developing, and structuring enterprises that will greatly enhance the economic and social arena of the Church, and its surrounding communities and the world.
  - b. To erect, maintain, secure, hold and possess lands, buildings for religious services, education and instruction.
  - c. To acquire, maintain, take hold by conveyance, bequest, gift, or devise, real and personal property for the purposes of the corporation; and to purchase, lease and erect buildings therefore; to take hold grants, donations, bequest and devise real and personal property, jointly and in trust, and apply the same, or the income thereof under directions of the trustees or officers of the corporation for the purposes thereof.
  - d. To accept property and donations in trust for religious or charitable purposes.

#### **ARTICLE IV - DURATION**

The duration of this Corporation shall be perpetual.

## **ARTICLE V – CAPITAL STOCK**

This Corporation shall be a non-stock, not-for-profit corporation.

## **ARTICLE VIII – MEMBERS**

Membership: This Corporation shall acquire membership solely for the purpose of progression of the vision embodied by this corporation, the church. There shall be no voting members in this corporation. Membership in the corporation shall be open to those who confess their faith in Christ and who embrace the beliefs and doctrines of this corporation also known as:  
TOTAL LIFE WORSHIP CENTER INC.

## **ARTICLE – IX 501(c)(3) LIMITATIONS**

**1. CORPORATE PURPOSES:** Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the internal Revenue Code of 1986 or the corresponding provision of any future United States internal Revenue law.

**2. EXCLUSIVITY:** The Corporation is organized exclusively for charitable, religious, and educational purposes.

**3. NO PRIVATE INUREMENT:** The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's charitable and educational purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.

**4. LOBBYING AND POLITICAL CAMPAIGNS:** No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

**5. DISSOLUTION:** Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to Total Life Worship Center or an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

#### **ARTICLE X – INDEMNIFICATION**

Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him (or by his heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties.

#### **ARTICLE XI – MODIFICATIONS/AMENDMENTS**

Modifications and/or amendments may be made to these Articles with majority approval of the Board of Directors. Majority is defined in the corporate bylaws.
