#### ARTICLES OF INCORPORATION

in compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

#### I. NAME

The name of this organization shall be the Association of Navy Chiefs in the Capital Region, Inc. The organization may also be referred to in this document by the acronym ANCCR or as simply the Association.

#### II. ADDRESS

The principal mailing address shall be:

#### III. PURPOSE

ANCCR is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- A. VISION: The vision of ANCCR is to focus the unique talents, experience and resources of all Navy Chiefs in the area served by the Tallahassee Navy Operational Support Center to support goals that bring credit on the Navy and reflect our shared history, traditions, values and leadership.
- B. MISSION: The mission of the Association is to support junior Sailors, fellow Chiefs and the local Navy community through activities that promote and encourage:
  - Increased awareness of Navy history, tradition and contributions,
  - Naval education, skills and career development,
  - Communication, fraternity & tradition within the Mess.

#### IV. MANNER OF ELECTIONS

- A. The Association shall be governed by an Executive Board of officers elected by the membership. This Executive Board shall be made up of a President, Vice President, Secretary, Treasurer and Master at Arms.
- B. Regular Elections, defined as those held at the end of each year for the purpose of filling all seats on the Board for the following year, will be held as outlined in the By-Laws.
- C. Following regular elections officers shall assume office on January 1<sup>st</sup> to serve a term ending on December 31<sup>st</sup> of the same year.
- D. The manner of election of the directors shall be as stated in the bylaws.

- B. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
- C. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- D. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### VI. DISSOLUTION
