ARTICLE IX

1 . This corporation is organized exclusively for charitable, religious, educational, artistic, entertaining and scientific purposes , as the making of distributions to organizations and that qualify as exempt organizations under Section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal, tax code.

2 . No part of the net earnings of the organization shall inure to benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purpose set forth in the purpose clause hereof.

3 . No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in or intervene in (including the publishing or distribution of statements) , any political campaign on behalf of any candidate for public office.

4 . Notwithstanding any other provision oft his document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under tax Section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or (b) by an organization, contributions to which are deductible under Section 170 (C)(2) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code.

5. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning Section 501 (C)(3) of the Internal Revenue Code, or
