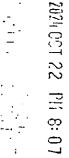

# AMENDMENTS TO ARTICLES OF INCORPORATION FOR MIRALAGO ESTATES I NEIGHBORHOOD ASSOCIATION, INC.

# Article 16.3.1 of the Articles of Incorporation are hereby amended as follows:

- 16.3. Approval. An amendment shall be approved once it is approved:
- 16.3.1. by Owners holding a majority of the voting interests in the Association present in person or by proxy electronic vote at a Members meeting at which a quorum thereof has been attained and by not less than sixty-six and two thirds percent (66-2/3%) of the entire Board; or
- 16.3.2. by Owners holding eighty percent (80%) of the voting Interests in the Association present in person or by <u>electronic voting proxy</u> at a Members meeting at which a quorum has been attained: <del>or</del>
- 16.3.3. prior to the date upon which Owners other than Developer control the Board, by not-less than one hundred percent (100%) of the entire Board.
