## Article III

The University Academy PTO is an organization whose purpose is to support the education of children at University Academy by fostering relationships among students, parents, teachers, and staff. It is our goal to foster a sense of support, pride and enthusiasm. This organization shall provide for school functions, engage in fundraising projects, encourage parent, teacher, and community involvement, and cooperate with school administration in providing educational opportunities.

Said organization is organized exclusively for charitable, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(C)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## Article IX

Upon the dissolution of the organization, assests shall be distributed for one or more exempt purposes within the meaning of Section 501(C)(3) of the the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assests not disposed of shall be disposed of by a court of

of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(C)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law
