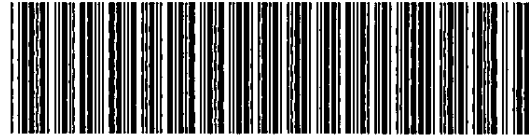

The undersigned, for the purpose of forming a non-for profit corporation under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I
[NAME]

The name of the corporation shall be **Breaking The Silent Cry Global Ministries, Inc.** (hereinafter called the "Corporation").

ARTICLE II
[PRINCIPAL OFFICE AND MAILING ADDRESS]

The principal office and mailing address of the corporation is **4700 Portofino Way, Suite 201; West Palm Beach, FL 33409.**

ARTICLE III
[PURPOSE]

The Corporation is a non-for profit corporation is for the charitable, religious educational training purposes in Section 501 (c) 3 of the Internal revenue Code 1966 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which non-profit corporation may be organized, so far as is or may be permitted by law of the State of Florida and Section 501 (c) 3 of the Internal Revenue Code 1986 as amended. Also, there will be several outreach programs organized to operate through: such as Conferences, Retreats, Radio Outreach Program (R.O.P.); Children Outreach Reading Program (C.O.R.P.) Women Health Initiative Program (W.H.I.P.); Prison Outreach Program (P.O.P.); Domestic Violence Outreach Program (D.V.O.P.); Safe Haven For Women (S.H.F.W.); Mothers of Grief Outreach Program (M.O.G.O.P.); Straight Talk Keep It Real (S.T.K.I.R.); Women In Ministry Connections (W.I.M.C.); Motivational Speaker (M.S.); Entrepreneurship Program (E.P.); Parent Educations Empowerment Program (P.E.E.P.); Personal Development (P.D.); Specialized Workshops (S.W.); Saving Our Daughters (S.O.D.); etc.

ARTICLE IV
[INITIAL REGISTERED OFFICE AND AGENT]

**ARTICLE VI
[INCORPORATION]**

The names and addresses of the person who shall serve as the Corporate Officer of the Corporation shall be **Dr. Mattie R. Shannon; 4700 Portofino Way Suite 201; West Palm Beach, FL 33409.**

**ARTICLE VII
[DISSOLUTION]**

Upon the dissolution of winding up of this corporation, its assets remaining after payment or provisions for payment of all debts and liabilities of the Corporation shall be distributed to a not-for profit fund, foundation or Corporation which is organized and operated exclusively for Charitable purpose and which has established its tax exempt status under Section 501 (c) 3 of the Internal Revenue Code 1986, as amended, or corresponding provision of any subsequent federal tax laws.

**ARTICLE VII
[LIMITATION]**

No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its director, officers, members, or other private person; except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of any of its purpose. No substantial part of the activities of the Corporation shall be carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501 (c) 3 of the Internal Revenue Code 1986, as amended) and the Corporation shall not participate or intervene in (Including the publishing or distribution of statement any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of those Articles , the Corporation shall not carry on any activities not permitted to be carried on (1) by a Corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Code 1986 as amended (or corresponding provision of any future United States Internal Law), or (b) a Corporation contribution to which are deductible under Section 170 (c) 2 of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).

The effective date shall be January 1, 2013.


