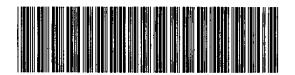

I HEREBY CERTIFY that the following amendments to the Declaration of Protective Covenants, Conditions and Restrictions for Palmer Estates, the By-Laws for Port Royal Estates Association, Inc., and the Articles of Incorporation for Port Royal Estates Association, Inc., were duly adopted by unanimous written consent of the Association membership.

A. AMENDMENTS CHANGING NAME OF ASSOCIATION

- I. Section E of the Background of the Declaration is hereby amended as follows:
 - E. Association shall mean and refer to PORT ROYAL ESTATES ASSOCIATION, INC., GORDON DRIVE ESTATES, INC., a Florida corporation not for profit.
- II. Article 18 of the Declaration is hereby amended as follows:
 - 18. ASSOCIATION: The Developer and each owner of a lot in PALMER ESTATES shall automatically upon recording of a deed conveying title to such owner,

become a member in the PORT ROYAL ESTATES ASSOCIATION, INC., GORDON DRIVE ESTATES, INC., subject to all powers, duties, dues, liens and assessments of such membership. The membership in such Association shall terminate upon conveyance by the owner of his title to the lot to another party or parties. III.
