

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PARTNERS N PROGRESS, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following amendments to its articles of incorporation.

FIRST:

Article I, Name of Corporation is hereby amended and shall hereafter read as follows:

<u>ARTICLE</u> I

NAME

The name of the corporation is PARTNERS N PROGRESS FOR THE ARTS, INC. (hereinafter referred to as "Corporation").

> Article IV, subparagraph A, Rurpose is hereby amended and shall hereafter read as follows:
