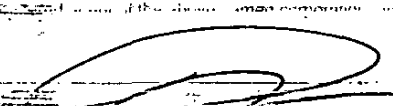

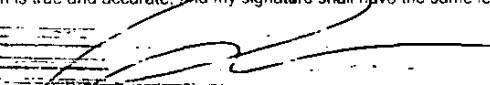

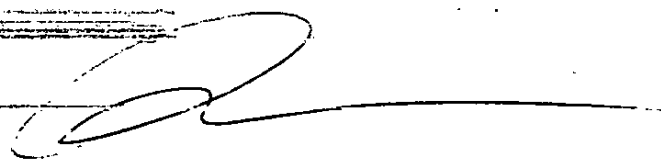
Dear Ms. Bailey,
