I am Mayte Vanegas, president of a Non-Profit Organization, "Colombian Disaster Fund, Inc." I'm sending another check No. 415 from Washington Mutual Bank for the amount of, \$61.25, to pay for the reinstatement of the organization.

I already sent a check No. 400, on August 2, 2004, for the same amount to reinstate the corporation, and you haven't received my payment yet. I spoke today with a lady from your office and told her that if you were to receive the other check, to please keep it in our account for the next upcoming year.

Also, your office has two checks already cashed under my account that I sent in 2002-2003, both for the amount of \$35.00. The first one was to be put under the name of: "Action Kind Relief, Fund", like "DBA", from Colombian Disaster Fund, Inc., but I never received any notice from your office. When I called your office, somebody told me that I can't do that; she recommended me to, register the name, Action Kind Relief Fund, like a fictitious name, and I did it, but we made a mistake, we sent the wrong form.

The problem is, my bank doesn't send me back my payable checks, and now they're looking for my checks and I've had to wait a few weeks to pay just so that I can get the copies of my checks.

Now, I would like to know, why is it that I can't use the Action Kind Relief Inc., as a "DBA", from the other foundation? If possible please send me my checks back along with your response. Thank you.
