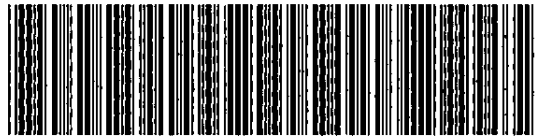

MINISTRIES, INC.


**SECOND:** Members of this corporation are not entitled to vote on a proposed amendment to the corporation's Articles of Incorporation.
