**RESTATEMENT
of
ARTICLES OF INCORPORATION
of
RUSHING WIND COMMUNITY CHURCH, INC.**

Pursuit to the provisions of section 617.1007, Florida Statutes, the undersigned Florida non-profit corporation adopts the following articles of amendment to it's articles of incorporation.

ARTICLE I: The name of the Corporation is: Rushing Wind Community Church, Inc.

ARTICLE II: The principle place of business and mailing address of Rushing Wind Community Church, Inc. is: 205 57th Avenue West, Bradenton, FL 34207.

ARTICLE III: The objects and purposes of this corporation shall be: to engage in any such religious, educational, literary, historical, philanthropic, and charitable pursuits as may be included within the following: (1) To function as and discharge the duties and responsibilities of a local church. (2) To promote, foster, maintain, and defend and otherwise propogate the faith and belief in the religious worship of God based on the teachings of Jesus Christ.

ARTICLE IV: All or any of the directors being appointed to the board of Rushing Wind Community Church, Inc. can only be done so by a majority vote of the existing board of directors annually or at any special meeting.






