ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF REGAL FOUNDATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

- 1. The current name of the corporation is REGAL FOUNDATION, INC.
- 2. The original Articles of Incorporation for the Corporation were filed on December 30, 1985, and assigned Document No. N12793, and amended on August 19, 1987.
- 3. Article VII, entitled "Membership," shall be amended to read as follows: "The members of this Corporation, if any, shall be qualified and admitted as set forth in the Bylaws of this Corporation."
- 4. Article IX, entitled "Initial Board of Trustee," shall be deleted in its entirety, and the following substituted in lieu thereof:

ARTICLE IX BOARD OF TRUSTEES AND OFFICERS

This Corporation shall have at least three (3) trustees. The number of trustees was been either increased or decreased from time to time as provided in the Bylaws, provided however number of trustees shall not be less than three (3).
