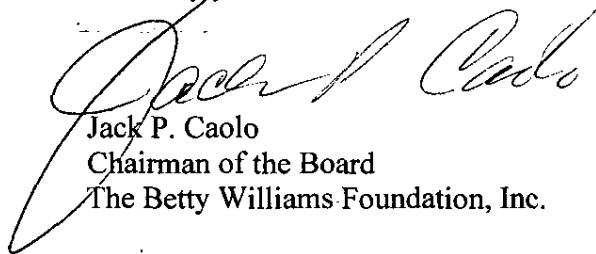
Dear Dept. of State:
