Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida corporation adopts the following amendments to its Articles of Incorporation.

1. Article I of the Articles of Incorporation of The Church at Merrill Road, Inc. is hereby amended in its entirety to read as follows:

"ARTICLE I  
Name

Section 1.1. Name. The name of the corporation shall be "Lakeview Christian Fellowship, Inc."
