## ARTICLES OF INCORPORATION

*Pursuant to Chapter 617, Florida Statutes, the undersigned Incorporator hereby forms IGM Foundation Inc., a Florida corporation not for profit, for the purposes set forth below, to be effective on December 28, 2012.*

### ARTICLE I NAME

The name of the corporation shall be:

IGM Foundation, Inc. (the Foundation)

### ARTICLE II PRINCIPAL OFFICE

The mailing address of this corporation shall be:

### ARTICLE III PURPOSE AND POWERS

1. The private foundation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the IRS code, or corresponding section of any future federal tax code
2. The private foundation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the IRS code, or the corresponding section of any future federal tax code.
3. The private foundation will not engage in any act of self-dealing as defined in section 4941(d) of the IRS code, or corresponding section of any future federal tax code.
4. The private foundation will not retain any excess business holdings as defined in section 4943(c) of the IRS code, or corresponding section of any future federal tax code.
5. The private foundation will not make any investments in a manner as to subject it to tax under section 4944 of the IRS code, or corresponding section of any future federal tax code.
6. The private foundation will not make any taxable expenditures as defined in section 4945(d) of the IRS code, or corresponding section of any future federal tax code.

7. Upon the dissolution of the private foundation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the IRS code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**ARTICLE IV MANNER OF ELECTION**

2. Directors of the Foundation shall be elected by the members in the manner determined by the Bylaws.
