#### Attachment to the Article of Incorporation of

### JWJ Raiti Foundation, Inc.

#### Article III:

This corporation is organized exclusively for charitable, religious, educational and scientific purpose, including for such purpose, the making of distributions to organizations that qualify exempt organizations under section 501 (c)(3) of the IRS code, or corresponding section of any future federal tax code. The specific purpose of this corporation is to provide support and assistance to needy, including children's, orphaned, abounded or whose families are unable to care for them.

#### Article VIII:

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) of the Internal revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the distribution of the organization, asset shall be distributed for one or more exempt purpose within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose, any such assets not disposed of shall be disposed of by the court of common pleas exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
