## Article I Name

The name of the corporation shall be **Keys Lifeline Ministry, Inc.**

## Article II Principal Office Address

192 Ocean Drive

Tavernier, FL 33070

## Article III Purpose

The mission statement of Keys Lifeline Ministry incorporated shall be "To help those in need". Our purpose will be to provide a lifeline of assistance to people of the Upper Florida Keys who find themselves in a difficult situation, helping them move toward a brighter day with dignity and hope. We shall seek **501(c)(3)** status from the IRS and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or other private persons, except to render services, payments and distributions in furtherance of our stated purpose. The corporation will not engage in political or legislative activity under 501 (c) (3).

## Article IV Manner of Election

The Directors shall be elected by a vote of the general membership, and those persons having the highest number of votes at a meeting at which a quorum is present shall be deemed to have been elected. Elections for the Board of Directors will be held every two years in the month of November. The Directors will take office beginning January 1 following the elections. Any vacancy occurring in the elected directors may be filled by the affirmative vote of the of the remaining directors. A director elected to fill a vacancy shall be elected for the unexpired term of his predecessor in office.

**Article V Dissolution**

Upon the dissolution of the Corporation, assets shall be distributed to one or more organizations with similar purpose to Keys lifeline Ministry Inc. , provided that such organization is an organization qualified under section 501 ( c ) ( 3 ) of the Internal Revenue Code.
