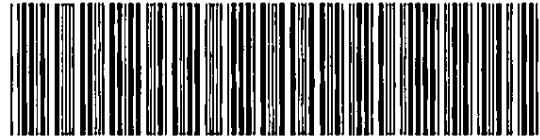

Gentlemen:


