#### Article 1 - Name

The name of this corporation is The Guardian Fund, Inc.



#### **Article 2 - Corporate Nature**

The Guardian Fund, Inc is a not for profit corporation organized pursuant to the Florida Not For Profit Corporation Act set forth is chapter 617, Florida statutes.

#### **Article 2 - Address of Principal Office**

#### **Article 3 - Purposes**

This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purposes are to educate and support individual Law Enforcement and US Military personnel who seek to enhance their overall firearms proficiency.

## Article 7 - Bylaws

**Article 11 - Limitations on Actions** 

- A. No part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- B. No part of the net earnings of this corporation shall inure to the benefit of, or be distributed to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
- C. Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

**Article 12 - Amendments** 

These Articles of Incorporation may be altered, amended or repealed only by a majority vote of the Board of Directors of this corporation.
