ARTICLE OF INCORPORATION ARTICLE 1 - NAME

The name of the Corporation shall be - Martyrs for Christ International Bible Ministries, Inc

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE (S)

Section 1: The Corporation is formed to provide - equip humanity to live a life of integrity and an authentic Christian life that transition them into true Martyrs for Christ and develop a peculiar Bible based people.

Section 2: The goals and purpose of the Corporation is to provide -

Each facet of Martyrs for Christ International School of Ministries is designed to transform humanity into the likeness of Christ.

Students will have comprehensive knowledge of how Jesus Christ lives in and through humanity.

Students will have a comprehensive knowledge of Bible truth and its relevance to life.

Students will have a comprehensive understanding of what the Bible means when it says know no man after the flesh (2 Corth. 5:15 – 16).

Students will have a comprehensive understanding of the importance of association with those that are striving to become more like Christ.

Students will have a comprehensive understanding of the Scripture which states, "Make you calling and election sure" (2 Peter 1:10).

Students will have a comprehensive understand the importance of the Scripture which states, "Study to hew thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth. (2 Timothy 2:15).

Section 3: The Corporation shall appoint a Board of Directors who shall have the power to overseer the operation of the Corporation, raise funds and over-see the distribution of funds.

Section 4: The Corporation shall have the power to function in all ways and extend its services as set- fort in the Article of Incorporation.

Section 5: The corporation shall be declared a non-profit organization and thus exempt from taxation.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS/OFFICERS

Section 1: The manner in which the directors are elected or appointed is, the original incorporator shall appoint the board of directors and its chairperson. These individual shall remain in office as long as they are willing to uphold the purpose, and goals of Martyrs for Christ International Bible Ministries, Inc.

Section 2: Directors and Officers may resign their position by sending a written statement to the registered agent.

Section 3: A director of officers may be asked to resign when the best interest of the Corporation is no longer demonstrated by his/her actions.

Section 4: the Board of Directors, upon consent to the Registered Agent and Director, shall make decisions in the operation of the Corporation.

Section 5: All new board members shall be approved by the Incorporator.

Section 6: The Board of Director shall consist of no less than three (3 and no more than seven (7) members.

Section 7: A quorum shall consist of members present.

ARTICLE V FINIANCIAL MATTERS

Section 1: The Corporation shall have the power to solicit donations from both public and private individuals/business, etc.

Section 2: Directors and officers shall receive compensation for expenses that are related t the operation of the Corporation.

Section 3: Employees shall receive a salary that is commensurate with salaries in similar businesses.

Section 4: All promissory notes, bonds deeds, and security deeds, mortgages and contracts of the Corporation shall be executed in the Corporation' name, and signed by the Incorporator or the Incorporator's appointee (s).

Section 5: Should the Corporation dissolve, after all indebtedness have been paid, the remaining funds shall be donated to another not-for profit organization.

ARTICLE VI - ADMENDMENT TO BY-LAWS

These by-laws may be amended, altered, or added to as deemed necessary to carry out the goal and purpose of Corporation.
