# **Certificate of Incorporation Attachment**

#### **ARTICLE III PURPOSE**

The specific purposes for which MIRACLEMED Organization, Inc. is organized are:

- 1. To support and benefit organizations dedicated to provide medical treatment, psychological assistance and comprehensive health care services to children diagnosed with cancer in low and non-income populations, who cannot seek medical treatment due to lack of financial resources or health insurance. Both, locally and in underdeveloped countries. One of MIRACLEMED Organization, Inc. goals is to be able to support the construction of treatment centers, and support other cancer related organizations in the area to facilitating transportation and housing for non-income parents or family members that cannot otherwise access the treatment center to obtain the much needed medical assistance.
- MIRACLEMED Organization, Inc. also aims these patients of low or non-income communities who are affected by other medical conditions by promoting patient and family education and preventive health services, in order to minimize hospital stay and prevent recurrent hospitalizations.
- 3. This corporation is organized exclusively for charitable purposes, including for such purposes, the making of distribution to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

# **ARTICLE VIII EFFECTIVE DATE AND DURATION**

The effective date for this corporation shall be **January**, **02**, **2013**. The period of duration of this corporation is: **Perpetual**.

#### ARTICLE IX ADDITIONAL PROVISIONS

 No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation (except as otherwise provided by section 501(h) of the Internal Revenue Code), and this corporation shall not

- participate in, intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in the opposition to, any candidate for public office.
- 2. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.

## **ARTICLE X DISSOLUTION**

The property of this corporation is irrevocably dedicated to charitable purposes. Upon dissolution or winding up of the corporation, its assets remaining after payment or provision for payment of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which organized and operated exclusively for such purposes. are
