Englewood Animal Hospital Foundation Incorporated Nonprofit

Articles of Incorporation $(Am \in NO \in D)$

The Englewood Animal Hospital foundation for the purpose of forming a corporation under the non profit laws of the state of Florida, hereby adopts the following Articles of Incorporation:

Article I

The Englewood Animal Hospital Foundation shall be a State of Florida Non Profit.

Article II

The term of existence shall be perpetual.

Article III

The purposes for which the corporation is organized are as follows:

The Englewood Animal Hospital Foundation has been organized to support groups and individuals who desire to provide high level routine, surgical, and emergency veterinary care but lack the financial wherewithal to pay. Recipients must provide documents to show they are receiving financial assistance or are on a fixed income.

*The Englewood Animal Hospital Foundation is organized exclusively for charitable, religious, educational, and scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

The Englewood Animal Hospital Foundation Nonprofit may therefore seek, apply for and receive donations, grants, loans, and other funding from individuals, organizations, corporations, government agencies, and others to support and conduct, in any manner, any lawful activities in furtherance of these charitable, scientific and educational purposes.

Notwithstanding any other provision of these By-laws, The Englewood Animal Hospital Foundation Nonprofit shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from federal income tax under Section 501(c)3 of Internal Revenue Code of the 1954 (or the corresponding provision of any future United States Internal Revenue Law; (b) a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding

provisions of any future United States Internal Revenue Law; or (c) a corporation under the Washington Nonprofit Corporation Act (RCW 24.03).

Article IV

The name of the registered agent is Affordable Veterinary Care Corporation and the chairman is Chris Gladieux, DVM. The street address is 340 North Indiana Avenue, Englewood Florida 34223. The mailing address for the Registered agent is 340 North Indiana Avenue Englewood Florida 34223.

Article V

There shall be five directors as the initial board of directors. Their names and addresses are as follows:

Article VI

*Upon dissolution of the Corporation, assets shall be distributed for one or more purposes within the meaning of the 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
