

Amendments to Articles of Incorporation <u>for</u> Peter London Global Dance Company, Inc.

A. Article IV (Purpose) is hereby amended as follows:

Article IV PURPOSE

The Non-Profit Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 as the same may be amended from time to time. The specific and primary purposes are:

- (1) To celebrate and share rich and diverse cultural heritages with people of all ages, ethnicities and socio-economic backgrounds while increasing awareness of our cultural similarities, global dance and music traditions.
- (2) To create new works by Peter London and perform these works throughout South Florida and globally thereby promoting the arts through global dance traditions.
- (3) To educate and train local dancers and present new works by local choreographers who have not traditionally had the opportunity to fully and professionally realize their tremendous talents and gifts.
- (4) To recognize individuals, organizations and institutions for their contributions, work, or role in promoting the work of the Peter London Global Dance Company.
- (5) To aid, support and assist by gifts, contributions or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable, religious, scientific, literary or educational purposes, no part of the net earnings of which inures to the benefits of any private shareholders or individuals, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
- (6) To do any and all lawful activities which may be necessary, useful or desirable for the furtherance, accomplishment, fostering or attainment of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature such as corporations, firms associations, trusts, institutions, foundations or governmental bureaus, departments or agencies.
- (A) In furtherance, but not in limitation, of the foregoing charitable, and educational purpose, the corporation shall have the following powers:
 - (1) To solicit, collect, and receive money and other assets, and administer funds and contributions received by grant, gift, deed bequest or device, and otherwise to acquire money, securities, property, rights and services of every kind and description, and to hold, invest, expand contribute, use, sell or otherwise dispose of any money, securities, property, rights or services so acquired for the purpose above mentioned;

- (2) To borrow money and to make, accept, endorse, execute and issue bonds, debentures, promissory notes, and other corporate obligations, for monies borrowed, or in payment for property acquired or for any of the purposes of the corporation, and to secure a payment of any such obligations by mortgage, pledge, deed, indenture, agreement or other instrument of trust, or by other lien upon, assignment of or agreement in regard to all or any part of the property, rights or privileges of the Corporation.
- (3) To furnish stipends, research advice or results, support, training and/or technical assistance to individuals, institutions, and/or groups in order to enable them to carry out the performances and work of the Peter London Global Dance Company;
- (4) To encourage and voluntarily assist individual, institutions or groups to organize, create, or support public forums, seminars, publications, brochures and any other undertakings that will appropriately advance the cause of educating people about the work of the Peter London Global Dance Company.
- (5) To exercise all other rights and powers conferred upon corporations formed under the General Non-Profit Corporation law of the State of Florida, provided, however, that the Company shall not engage in any activities or exercise any powers, including those specifically mentioned herein, that are not in furtherance of the specific and primary charitable, and educational purpose of the corporation.
- (B) All of the foregoing purposes and powers shall be exercised exclusively for the charitable and educational purposes in such manner that the company shall qualify as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1954.

B. Article XIII (Debt Obligations and Personal Liability) is added as follows:

Article XIII DEBT OBLIGATIONS AND PERSONAL LIABILITY

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the officers or Directors be subject to the payment of the debts or obligations of this corporation.
