NONPROFIT ARTICLES OF INCORPORATION

ASPIRING ATHLETES OF CENTRAL FLORIDA, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not-For Profit Corporation Act, section 617, Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be:

ASPIRING ATHLETES OF CENTRAL FLORIDA, INC.

ARTICLE - II - EXISTENCE

The Non-profit Corporation shall have perpetual existence.

ARTICLE - III - PRINCIPAL OFFICE

The principal headquarters and mailing address of this organization shall be:

ARTICLE - IV - PURPOSES AND OBJECTIVES

The specific purpose for which the corporation is organized is:

- A. To organize and operate exclusively as a not - for -profit Corporation to organize juvenile programs in the community for the development of male and female baseball and softball players within the ages of 12-18 years old.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign a behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities

not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

- B. To sell, distribute, purchase or acquire in any lawful manner sports literature in the form of book, tape, disk, cassette, compact disk, or in any other possible form.
- C. To invest the funds of this corporation in real estate, mortgages, or any other type of investment, and to own real and personal property necessary for the corporation purposes.
- D. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objectives or the furthermore of any of the purposes enumerated in these Articles of Incorporation or any amendment hereof necessary and incidental the protection and benefit of the corporation, and, in general, either alone or in or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or objectives of this corporation.
- H. The foregoing paragraphs shall be construed as enumerating both Objects and purposes of this nonprofit corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the the purposes of this corporation otherwise permitted by law.

ARTICLE V - MANNER OF ELECTION OF DIRECTORS





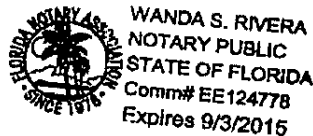
