

ARTICLES OF INCORPORATION FOR CHURCH OF MANY WATERS, INC

ARTICLE I- NAME

The name of this Corporation is CHURCH OF MANY WATERS, INC

ARTICLE II- PRINCIPAL OFFICE

The principal place of business address of this Corporation shall be: 563 Ferguson Dr., Suite E

The duration of the Corporation shall be perpetual.

ARTICLE III- NATURE OF BUSINESS

local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.


