#### ARTICLES OF INCORPORATION

OF

#### COMITE INTERNACIONAL DE EX PRESOS POLÍTICOS CUBANOS INC./GRUPO DE TRABAJO (A corporation not for profit)

The undersigned acting as subscriber(s) of a Corporation under the Non-Profit Corporation Law adopt the following Articles of Incorporation for such Corporation.

#### ARTICLE I

The name of the Corporation shall be COMITE INTERNACIONAL DE EX PRESOS POLITICOS CUBANOS, INC./GRUPO DE TRABAJO.

#### ARTICLE II

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)((3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial pate of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE V

This Corporation shall have perpetual existence.

#### ARTICLE VII

The affairs of the Corporation shall be managed by the Board of Trustees as provided in the By-Laws.

#### ARTICLE VIII

#### ARTICLE IX

Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
