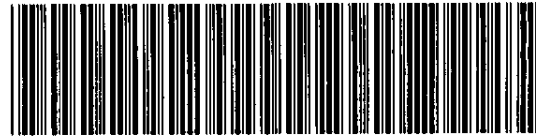

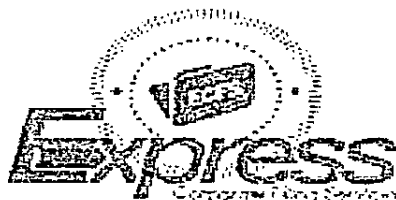

ARTICLES OF INCORPORATION
OF
COMITE INTERNACIONAL DE EX PRESOS POLITICOS CUBANOS INC./GRUPO DE TRABAJO
(A corporation not for profit)

The undersigned acting as subscriber(s) of a Corporation under the Non-Profit Corporation Law adopt the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the Corporation shall be **COMITE INTERNACIONAL DE EX PRESOS POLITICOS CUBANOS, INC./GRUPO DE TRABAJO.**

ARTICLE II

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE III

The names and addresses of the persons who are the initial Trustees of the Corporation are as follows:

ARTICLE IV

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

This Corporation shall have perpetual existence.

ARTICLE VII

The affairs of the Corporation shall be managed by the Board of Trustees as provided in the By-Laws.

ARTICLE VIII

The initial post office address and principal office of the Corporation in the State of Florida, shall be at 756 W. 53 TERR. HIALEAH, FL 33012.

ARTICLE IX

The initial registered agent and registered address of this Corporation is Orlando Martinez, 756 W. 53 TERR. HIALEAH, FL 33012. The Board of Trustees may from time to time move the principal offices to another address within the State of Florida.

ARTICLE X

The Corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the By-Laws.

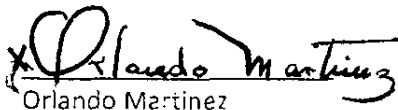
ARTICLE XI

The number of Directors shall be no less than three no more than fifteen at any moment.

ARTICLE XII

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
