Southeast Florida Women's Lacrosse Officials CONSTITUTION AND BYLAWS

CHAPTER 1: INTRODUCTION

- **Section 1.1:** Bylaws of the Southeast Florida Women's Lacrosse Officials (hereafter "SFWLO").
- **Section 1.2:** These Bylaws are to be interpreted consistent with the Bylaws of U. S. Lacrosse, Inc., the Women's Division of the College Officials' Council (hereafter "USL"), and the Florida High School Athletic Association (hereafter "FHSAA").
- **Section 1.3:** SFWLO shall be recognized annually by the FHSAA and is subject to the policies of the FHSAA in so far as they affect and prescribe the duties and responsibilities of this association and its individual members when officiating FHSAA recognized games.

CHAPTER 2: PURPOSE OF THE ORGANIZATION

To provide standardized officiating techniques by providing qualified officials to service all organizations, leagues, youth leagues and schools including, but not limited to public schools, private schools, colleges, universities. SFWLO will provide training for new officials and recertification clinics for existing officials to be current in rules interpretation and rules implementation, procedures and mechanics.

CHAPTER 3: PHILOSOPHY OF THE ORGANIZATION

An official is an integral part of the freedom, flow, and spirit of the game of women's lacrosse. It is necessary that the official shall have thorough knowledge of the game, personal integrity, and the ability to sustain physical effort. The official must also be concerned with encouraging the highest possible level of play, safety and sportsmanship.

CHAPTER 4: MEMBERSHIP

- **Section 4.1:** In order to officiate games in the South Florida Chapter of US Lacrosse area, women's lacrosse officials must maintain membership with USL. Officials (over age 18) must be a member of FHSAA to officiate middle school and high school games in Palm Beach County.
- **Section 4.2:** Rated officials are defined by the Women's Division Officials Council of U.S. Lacrosse, Inc. Rankings for Officials are defined by the FHSAA. The current year of <u>FHSAA</u>
