Attachment to Articles of Incorporation of the New Universal Church, Inc.

Purpose: This corporation is exclusively for charitable, religious, educational, and scientific purpose, including for such purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to corporations that qualify as exempt corporations under said Section 501(c)(3) of the Internal Revenue Code of the 1986. Specifically, the corporation will be a church that preaches and teaches to help any and all who ask to find their spiritual truth, regardless of race, gender, background, lifestyle or other church affiliations. We strive to live in harmony with nature and acknowledge the sanctity of all life.

Notwithstanding any other provision of this document, this corporation shall not carry on any activities not permitted to be carried on by an corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

No part of the net earnings of the corporation shall inure to the benefit of any trustee, director, or officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no trustee, director or officer shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the corporation.

No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

Upon the termination, dissolution or final liquidation of the Corporation, in any manner and for any reason, the Board of Directors shall first pay or provide for the payment of all liabilities of the Corporation; all remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such corporation or corporations, as said Court shall determine, which are organized and operated exclusively for such purposes.
