## Article I: Name and Principal Office

The name of this corporation is Siena Phase 2A and 2 B II at Renaissance Homeowners' Association, Inc., a Florida not-for-profit corporation (hereinafter called the "Association" in these Articles. The principal office and mailing address of the Association is 10150 Highland Manor Drive, Suite 200, Tampa, FL 33610, 611 Destiny Drive Ruskin, FL 33570.

## Article VII: Management

Board: Officers. The affairs of the Corporation shall be managed by its Board of Directors, which shall consist of not less than three (3) nor more than seven (7) individuals, the precise number to be fixed in the By-Laws or by the Board of Directors from time to time. Except as may be otherwise provided in the By-Laws, Directors shall be elected for one year terms by the Members at the annual Members' meeting, to be held as scheduled by the Board of Directors in the last quarter of each fiscal year in the manner prescribed in the By-Laws of the Association, and shall hold office until their respective successors are duly elected and qualified. The Board shall elect a President, a Vice President, and a Secretary-Treasurer, and a Treasurer of the Association, and such other officers as may, in the opinion of the Board, from time to time be necessary to adequately administer the affairs of the Association. Such officers are to hold office at the pleasure of the Board or until their successors are duly elected and qualified. Officers may be Directors. Officers and Directors must be Members of the Association-except-with-respect to those who are appointed by the Class B Members. Any individual may hold two (2) or more-corporate offices, except that the offices of President and Secretary-Treasurer may not be held by the same person. The office of President and Vice-President shall not be held by the same person. The person holding the office of Treasurer shall not hold any other officer position. Notwithstanding the foregoing, all other offices may be held by the same person, provided that one person may not hold more than two officer positions. The officers shall have such duties as may be specified by the Board or the By-Laws of the Association. Vacancies occurring on the Board and among the officers shall be filled in the manner prescribed by the By-Laws of the Association.
