ARTICLES OF INCORPORATION OF IGLESIA LA VERDAD, INC.

In compliance with Chapter 617, F.S. (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

First: The name of the Corporation shall be Iglesia La Verdad, Inc.

Second: The place in this state where the principal office of the Iglesia La Verdad, Inc. is to be located is the City of Tampa, in Hillsborough County.

The **principal address** of Iglesia La Verdad, Inc. is 8916 N. Nebraska Avenue, Tampa, FL 33604.

The **mailing address** of Iglesia La Verdad, Inc. is P.O. Box 82014 Tampa, FL 33682.

Third: The purpose for which the Iglesia La Verdad is organized is to spiritually lead individuals to a closer walk with God, help them overcome poverty, provide spiritual guidance as well as food and clothing not limiting the opportunity to provide a basic form of shelter and/or necessary referral service for this provision. Iglesia La Verdad, Inc. intends to set a foundation that fosters broad community social and spiritual growth, by providing educational programs, services, and/or resources to nearby residents. Iglesia La Verdad, Inc. seeks to provide after school care for children and youth of its members as well as nearby community.

Fifth: No part of the net earnings of Iglesia La Verdad, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that Iglesia La Verdad, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of Iglesia La Verdad, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Iglesia La Verdad, Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, Iglesia La Verdad, Inc. shall not,

except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
