ARTICLES OF INCORPORATION (Not for Profit) OF

PEACE Fam, Inc.

Article I - Name

The name of the Corporation shall be PEACE Fam, Inc.

Article II - Principal Office

The principal address of the Corporation is 7200 Aviation Blvd., Boat Slip #2, Marathon, Florida 33050. The mailing address of the Corporation is 5409 Overseas Highway, #119, Marathon, Florida 33050.

Article III - Purpose

The specific purpose for which this Corporation is organized is to bring people together to enhance their appreciation and understanding of wildlife conservation, the Earth's natural resources, and one another. In furtherance of the Corporation's educational and charitable mission to promote peace, healing, conservation and preservation of our planet, the Corporation will, among other things: (1) maintain a wildlife conservation sanctuary, and (2) provide transient educational animal exhibits for wildlife conservation and educational purposes at a grassroots level for students in kindergarten through 12th grade.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under

Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
