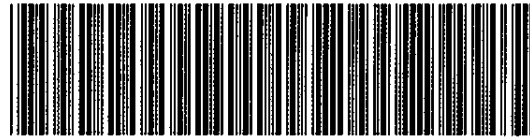

**ARTICLES OF INCORPORATION OF PROGRESS FLORIDA EDUCATION
INSTITUTE, INC.**

(In Compliance with Florida Statutes Chapter 617, Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Progress Florida Education Institute, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1010 Central Avenue, #209, St. Petersburg, Florida 33705.

ARTICLE III PURPOSE

The corporation is formed for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, including but not limited to raising public awareness and educating citizens about progressive thinking and ideas in the state of Florida. The corporation is not organized for private gain or individual profit. The original Board of Directors shall be appointed by the incorporator. The method of election of future boards shall be set forth in the Bylaws of the corporation.

The name of the incorporator is Mark Ferrulo. His address is 1010 Central Avenue, #209, St. Petersburg, Florida 33705.

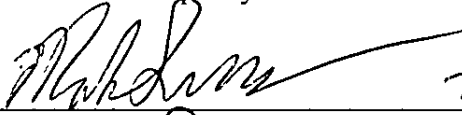
ARTICLE VIII DISSOLUTION
