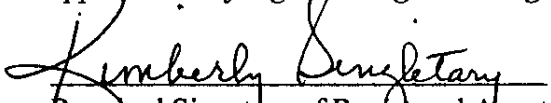

ARTICLE VIII – DISSOLUTION

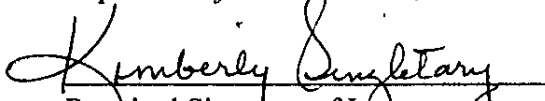
