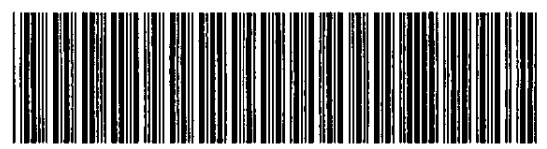

Article III: Purpose (add the following to existing language):

The specific purpose of this organization is to enhance the art, education, and entertainment of classical music for those young and developing student who are interested in learning and who may plan to make their life's career in this area of education. In addition, it is our objective to make this education available to any and all students, regardless of color, race, religion or their ability to pay for these services. Our educators and artist all will donate their time and effort into this educational endeavor for the benefit of those individuals who seek this art form.

This organization is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, if the named beneficiary at the time of dissolution may not be qualified, may not be in existence, or may be unwilling or unable to accept the assets of the dissolving organization, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and scientific purposes, and which has established its tax status under Section 501(c)(3) of the Internal Revenue Code. No Officer, director or member of the Corporation shall have a direct or indirect financial interest in the Corporation's interest when it is contemplating entering into a transaction or arrangement that might result in a possible excess benefit transaction. This policy is intended to supplement, but not replace any applicable state or federal laws governing conflict of interest applicable to non-profit and charitable organizations.

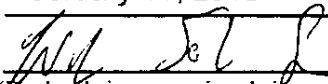
