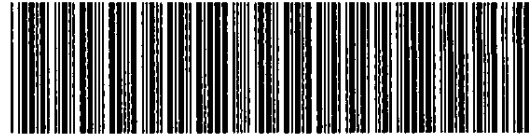

ARTICLES OF INCORPORATION  
In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I. NAME

The name of the corporation shall be Time 2018 Facilities Corp.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSE

- (a) Time 2018 Facilities Corp. is organized exclusively for fraternal, religious, charitable, scientific, literary, and educational purposes. It will be a domestic fraternal order as described in IRC 501(c)(10) and will devote its net earnings exclusively to fraternal, religious, charitable, scientific, literary, and educational purposes.
- (b) The specific purpose for Time 2018 Facilities Corp. is to plan and produce the 2018 General Assembly of the General Grand Chapter of the Order of the Eastern Star, a IRC 501(c)(10) exempt fraternal order. The General Assembly is required by the Constitution of the General Grand Chapter of the Order of the Eastern Star and is the event at which several thousand delegate and non-delegate members meet in a fraternal setting to elect General Grand Chapter officers, amend its laws and otherwise make decisions regarding the fraternal order. The 2018 General Assembly will be held in Florida.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The initially appointed directors will serve for a period of ten years. Vacancies created by expiration of the term of service, resignation, disability, death or otherwise, shall be filled by a vote of a majority of the directors at a regular or special meeting of the Board. All directors and officers of Time 2018 Facilities Corp. must be members, in good standing, of the Order of the Eastern Star.

ARTICLE VI. RESTRICTIONS ON NET EARNINGS DISTRIBUTION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(10) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII. ASSET DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(10) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


