January 27, 2013

Meeting of incorporation came to order at 8:00 pm, opening prayer was lead by Mr. Luis Alvarado. He then announced that he was being led by the Spirit of the Lord to reestablish a work (Warriors for Christ Bible Band, Inc.) that had begun in Kansas. He then turned the meeting over to Mr. Cleve Tucker. Mr. Tucker began to explain what it means to be a Non-For-Profit organization and how it relates to running a church. He further described the different offices/titles and their responsibilities. He explained how offices were to be selected and how meetings should be held. He asked if anyone had any questions. Ms. Denise Brown asked how many offices could be held by the same person. Mr. Alvarado inquired about the registered agent position and the different filing fees. Mr. Tucker then turned to the meeting back into the hands of Mr. Alvarado. Mr. Alvarado explained that a regular annual meeting of the Board of Directors shall be held without other notice than in bylaws, immediately after, and at the same place as the annual meeting of members. He also, went on to say that the affairs of the incorporation shall be managed by its Board of Directors. He expressed that the church belongs to the people and the people are the church and therefore; the Tithes will be used to meet the monthly expenses of the incorporation along with any other overhead liability that may occur. Officers were then nominated then selected. With no other questions, the meeting was adjourned at 9:20 by Mr. Alvarado.
