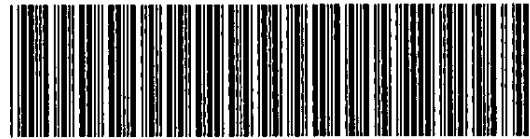

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: No part of any earnings of the corporation shall inure to the benefit of, or be distributable to its

(A) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (B) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

We will feed the hungry; give to the needy of the community and ensure various programs are in place to increase the education of the individuals that connect with this corporation.


