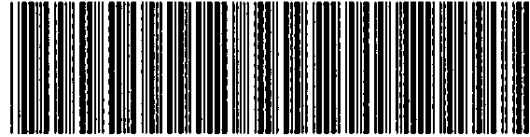

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation hereby adopts the following Articles of Incorporation:

ARTICLE I NAME:

The name of the corporation shall be:

VOTE ESTERO 2 INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the Corporation is organized is:

To assure and provide the registered voters of the community of Estero in Lee County, Florida, their constitutional right of electoral franchise by referendum, to address issues within the community of Estero, concerning the quality of life, improve public services, preserve community traditions, planning and zoning of real properties, architectural appearance of structures, establish a local elected government and such other and further purposes as may be permitted by state and federal statutes for not for profit corporations specifically pursuant to section 501 (c) (4) of the The Internal Revenue Code.

ARTICLE IV BOARD OF DIRECTORS

The Board of Directors of the Corporation shall be elected or appointed in accordance with the methods and qualifications specified in the bylaws of the Corporation. In no event shall the number of directors be fewer than three (3).




