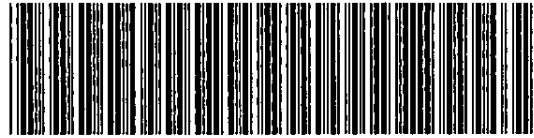

Upon termination or dissolution of Springhill RYO club, Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of Springhill RYO club, Inc. hereunder shall be selected by the discretion of a majority of the managing body of Springhill RYO club, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Springhill RYO club, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

ARTICLE IX MEMBERS

The first Members of the Springhill RYO club, Inc. shall be the persons subscribing to these Articles of Incorporation. Membership in the Springhill RYO club, Inc. shall be open and granted to all persons and organizations exercising an interest in health and wellness, in such capacities and categories, and in such manner and on such terms, as may be determined by Bylaws.
