**Articles of Incorporation
of
The J House, Inc.
A Florida Corporation Not for Profit**

The undersigned incorporator, for the purpose of forming a corporation not for profit under the laws of the State of Florida, hereby adopts the following articles of incorporation:

Article 1

CORPORATE NAME

The name of the Corporation is The J House, Inc.

Article 2

ADDRESS

The street address of the initial principal office and the mailing address of the Corporation is: 9273 SW 8th Street, Suite 123, Boca Raton, Florida 33428.

Article 3

PURPOSES

The Corporation is organized exclusively for charitable, educational, religious and/or scientific purposes within the meaning of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code. Specifically, the Corporation is organized to support the establishment of living environments for young adults with disabilities such as Multiple Sclerosis and Cerebral Palsy, with the goal of helping such young adults live independently. By the creation of holistic, forward-thinking living environments which afford young adults with disabilities easy access to services such as nutrition, therapies (massage, reflexology, occupational therapy, physical therapy, chiropractic, acupuncture), social work, medical benefits, and transportation, the Corporation will seek to foster wishes of wellness and dreams of living independently with the support and camaraderie of a home.

Article 4

MANAGEMENT OF CORPORATE AFFAIRS

The powers of this Corporation shall be exercised, its properties controlled and its affairs conducted by a Board of Directors consisting of not less than three (3) persons, who shall be elected and appointed as set forth in the Corporation's Bylaws. The initial number of Directors of the Corporation shall be three (3); provided, however, that such number may be increased or decreased (but not below three) by the Board of Directors from time to time as provided in the By-Laws.
