**AMENDMENT TO ARTICLES OF INCORPORATION
OF
FOUNDATION FOR HOPE, INC.**

This Amendment to the Articles of Incorporation is filed pursuant to Section 617.1007 of the Florida Not For Profit Act (the "Act") to reflect an amendment to the Articles of Incorporation of FOUNDATION FOR HOPE, INC., originally filed on February 18, 2013, and amended and restated in its entirety on March 18, 2013. This is a non-membership corporation as allowed in Section 617.0601 of the Act, and thus, in accordance with Section 617.1002(1)(b) of the Act, the undersigned directors of the corporation unanimously adopted a resolution approving this Amendment to the Articles of Incorporation on November 26th, 2013, and hereby set forth this Amendment to the Articles of Incorporation as follows:

1. The name of the corporation is FOUNDATION FOR HOPE, INC.
2. The name of this corporation shall be changed by deleting the provisions of Article I. of the Articles of Incorporation and by substituting the following Article I. of the Articles of Incorporation to read in full as follows:

"ARTICLE I.- NAME

The name of the corporation shall be the CRAWFORD FAMILY FOUNDATION FOR HOPE, INC."

This Amendment shall be effective upon the filing of this Amendment by the Department of State.
